## 2. COMPOSITION/INFORMATION ON INGREDIENTS

All contents quoted relate to dry weights of product. In the aqueous suspension state, minor amounts of organic binders / biocides and identification dye-stuffs may also be present. When dry, this material offers the normal hazards associated with any dry powder of a slightly abrasive nature. In dry state, forms low toxicity dust with an occupational exposure value of 10 Mg/M3 (nuisance dust).

## 4. FIRST AID

## 7. HANDLING & STORAGE
